HARC's energy research program includes identifying and supporting cost-effective, practical energy solutions to speed the transition to a decarbonized system. Making the transition to clean energy will require a coordinated effort led by non-partisan entities. HARC's continued effort will guide policymakers and industry leaders toward improvements in areas such as electric power resilience, energy efficiency, distributed energy resources, and low impact oil and gas exploration.

HARC's water research program emphasizes water quality and quantity, watershed management, biodiversity and ecological function, and ecosystem informatics. HARC compiles and analyzes numerous databases describing environmental quality, biological and water resources, and aquatic and terrestrial habitats. Integration, analysis, and dissemination of information regarding important water issues is considered key to advancing more sustainable management of coastal watersheds, water supplies, and water quality.

HARC's air quality research and management program includes air quality modeling, emission reduction technologies, emissions monitoring technology and policy. The result is a dynamic partnership that integrates rigorous research and policy assessment in a way that has become a HARC trademark in the region.
